Design, fabrication and installation of Auto Clave machine
in the Bridgestone tire factory in Stargard - stage 1B according to the Alternative

1. Subject matter of the contract

The subject matter of the contract is “Design, fabrication and installation of Auto Clave machine in the Bridgestone tire factory in Stargard - stage 1B according to the Alternative Design acc. to PR11545204”

Auto Clave machine will be use in laboratory for quality test and checking of final rubber products.

The contractor should provide:

- a qualified team (as specified)
- materials and tools necessary to conduct works (as specified).
- have the necessary experience and qualifications.

Employer provides complete technical documentation necessary for the execution of the contract. The detailed specification together with the complete tender material will be made available to interested companies after they sign declarations of confidentiality

3. Selection of bids

The Employer shall select the best bid from among the not rejected bids based on the evaluation criteria.

The most favorable balance of the following criteria shall be taken for selection of the bid:

- Experience in performing the works constituting the subject matter of the contract (as specified)
- Service deadline
- Price

When the tender was closed without selecting any of the bids, in particular when the conditions of the proposed works differ significantly from expectations of the Employer, the Employer may not select any of the offers. The Employer will then enter into negotiations with bidders who had the most favorable balance of the above criteria.
